

Cookies Policy

At Transinsular customer protection is a concern without exception, always aware that the exchange of data between users and the Internet requires maximum security in the information collected.

The use of cookies allows customers to access more efficiently and quickly. All information given is treated confidentially and in accordance with all data protection laws. Transinsular assumes the commitment to the privacy of all information collected.

All data provided can be accessed, altered or deleted by its owners, and for this purpose the customer can make a simple request addressed to Transinsular.

What are cookies?

"Cookies" is a text string stored in a specific file and included in Hypertext Transfer Protocol (HTTP) requests and responses. It allows you to record status information while you browse and when you return to a specific website, maintaining HTTP sessions.

Why are cookies used?

- For the website to work more efficiently and faster;
- Improve the level of security when using some restricted area;
- Help collect information that can best serve your interests;
- Collect statistical information to improve how you relate to customers and products.

Benefits to customers or users:

- More safety;
- Do not repeatedly receive questions or information already viewed;

Some disadvantages:

- Some cookies may be installed on the user's browser for some time;
- Some cookies can monitor the user's route through the company's website.

What kind of cookies Transinsular uses:

- Essential mandatory for the proper functioning of the Internet site (login of users);
- Non-Essential although not breaking the proper functioning of the website it's used to improve user interaction;
- Little Intrusive it is used in the user's observation but does not provide any kind of personal information (Google's Analytics);
- Very Intrusive it is used for the observation of the user, providing personal data. This classification only serves as a reference; it can create a totally new or adapt this to others and vice versa.
